



# FUTURITY RULES 2009

- The following classes will be offered and held as long as there are at least three (3) paid entries in each class:

- 2009 Stallions and Solid Paint Bred Stallions
- 2009 Fillies and Solid Paint Bred Fillies
- 2008 Stallions and Solid Paint Bred Stallions
- 2008 Fillies and Solid Paint Bred Fillies
- 2008 Geldings and Solid Paint Bred Geldings
- Yearling Longe Line (Solid Paint Bred Included)
- Two Year Old Western Pleasure (Solid Paint Bred Included)
- Three Year Old Western Pleasure (Solid Paint Bred Included)

- Yearling In-Hand Trail (Solid Paint Bred Included)

- Entries must be paid by August 10, 2009 according to the payment schedule.  
**Late entries will be accepted until 5PM September 10, 2009.**
- All horses must be registered with APHA. Copies of the registration papers are due with the first payment. Weanlings may register with a copy of the work order number from APHA and a copy of registration application.
- You must be a member in good standing with the APHA to exhibit.
- All listed owners on the entered horse's papers must be members of the HPPHC and must include membership dues with the first payment. (For example – if the horse's papers list Bob and Jane Smith, then both Bob and Jane Smith must also be members of HPPHC)
- Substitutions will be allowed with an additional fee of \$25.00.**
- Moneys will only be refunded upon presentation of a veterinarian certificate stating the horse has died.
- Should the horse be sold, the new owner must become a member of HPPHC and a copy of the transfer sent to the HPPHC chairperson.
- Futurity entries **may** be shown in their respective open class for no additional fee.
- There will be added money in each class that is filled.
- The futurity committee reserves the right to cancel, or make changes that are necessary.
